Session Overview

Under traditional Medicare, beneficiaries generally qualify for Medicare-covered skilled nursing facility (SNF) rehabilitation only after a **3-day inpatient hospital stay** (observation or ER time does not count) or a prior SNF stay.

However, Medicare now offers a **waiver for beneficiaries enrolled in certain Accountable Care Organizations (ACOs)**. This waiver may allow coverage for SNF care **without a 3-day hospital stay**, including direct admission from a physician's office or a shorter hospital stay. Because this option is not widely known, many beneficiaries are unaware of whether they qualify.

This **Teach-In** will explain how the waiver works and how beneficiaries can find out if their **SNF rehabilitation may be covered under Medicare Part A**.
